\* The Society follows the policy of the National Society regarding credit of dues paid by new and reinstated members.

\*\* The NSSAR Application Copy fee is charged if the applicant cannot be found in the National membership database or cannot supply a Record Copy of his membership application form.

(1) The NSSAR application fee is reduced from \$80 to \$30 (1) when additional family member applications are submitted at the same time, provided that each additional application is on the same genealogical line.

(2) Junior members do not have voting rights and do not receive the National SAR magazine. At 18 years of age, they automatically become regular SAR members and start to receive the SAR magazine. They can maintain a C.A.R. membership in addition to their NSSAR membership.

(3) The NSSAR application fee shall be waived if the male applicant has not attained the age of 22, is a member in good standing of the Children of the American Revolution (CAR), has been elected a member of a state society of SAR and presents a certificate attesting CAR membership to the Registrar General.

(6) For each additional family member's simultaneous supplemental application for the same Patriot, the NC fee will be \$ 7.50 per applicant.

(7) Graduated fee for [National Life Member](#) is \$900 if 18 to 40 years old, then decreases \$15.00 each year to \$600 at 60 years old. State Dues must be paid to the NC State Society each year to maintain life membership.

(8) For deceased father or grandfather (within 2 generations) of active SAR member.
