The NC Society follows National Society policy, Fees & Dues must be submitted together for each New Applicant or Reinstatement-Transfer. For ONS+ - New Member applicants who wish to join the Old North State Chapter require an additional \$15 NC SAR fee cover cost of SAR Rosette

- \* SAR Members who wish to Transfer or be Reinstated into NC Society must provide a Record Copy of their SAR Membership Application. Upon payment of \$10 Copy Fee by the Applicant the National Society will provide a Record Copy to the State Society.
- (1) The NSSAR reduces its application fee \$50, from \$80 to \$30, when additional family member applications are submitted at the same time, provided that each additional application is on the same genealogical line.
- (2) Junior members do not have voting rights and do not receive the National SAR magazine. At 18 years of age, they automatically become regular SAR members and start to receive the SAR magazine. They can maintain a C.A.R. membership in addition to their NSSAR membership.
- (3) The NSSAR waives its App Fee if the male applicant has not attained the age of 22, is a member in good standing of the Children of the American Revolution (C.A.R.), has been elected a member of a state society of SAR and presents a certificate attesting CAR membership to the Registrar General.
- (4) Submit form # 0919 Transfer Application form
- (5) Submit form # 0918 Reinstatement-Transfer Application form
- (6) Submit form # 0920 Dual Membership Application form
- (7) For each additional family member's simultaneous Supplemental Application from the same Patriot, the NC fee will be \$ 7.50 per applicant.
- (8) National Life Member fee is graduated and starts at \$1040 at 1 year old and decreases each year to \$0 at 100 years old. State Dues must still be paid to the NC State Society each year to maintain your membership.
- (9) Nat Clark State Life Member fee is \$600 from 18 to 40 years old, then decreases yearly to \$0 at 100 years old.
- (10) The Memorial SAR Membership qualifies a male who is a deceased close relative within two genealogical connections to an active SAR member and whose application is based on most of the same lineage as that SAR member.
